- Signed “Client Information Form”
- Signed “Engagement Agreement”
- Signed “Audit Protection Form”
- Social Security Cards for identification (only if asked)
- **DRIVERS LICENSE (only if changed)**
- Proof of residency if you are claiming children (school or medical documents)
- Form 8332 or statement releasing exemption for child
- **1095A, B or C Health Insurance Form**
- **1099-H Health Coverage Tax Credit Advance Payments**
- W-2 Forms for all Wages
- 1099 Forms for:
 - Interest Income
 - Dividends Income
 - Retirement Income
 - Social Security Income
 - Unemployment Income
 - Gambling Income
 - Other income
 - 1099-G State Taxable Refund
 - K-1 Form (Interest in Partnerships, S Corp, Estate, etc.)
 - Bit Coin Transactions
- Alimony Received & Divorce Date
- All other statements of income
- Rental income and documented expenses

- Self-Employment income and expenses
(Schedule C Input sheet from website)
- Mileage for rental and self employment is different for Jan – Jun so need these miles then Jul – Dec need these miles PLUS need total miles for Jan – Jun and Jul – Dec (see schedule C and E input sheets)

- **Medical Expenses and Medical Mileage if over 7.5% of AG I**
- **Real Estate Tax Statements for any property you own**
- **Vehicle Registration with Property Tax Paid for vehicles, campers, boats, trailers, etc. (only property tax is deductible)**
- 1098 Forms for Mortgage Interest
- **Receipts for donations of money to charity**
- **Receipts for donations of property to charity**
- **Volunteer mileage**
- Higher Education Expenses (tuition, books, and fees) with proof of payment
- Child Care Expenses - letter from provider with provider’s name, address, EIN or SS#, amount pd for each child
- Settlement papers - if you bought or sold a house
- 1099 S for sale of home (check closing papers)
- Adoption Expenses
- Estimated Tax Payments - dates and payment amounts
- Foreign Accounts - Bank Statements
